A stormy Christmas day, mild, and heavy showers.

SALT SPRING ISLAND.

A concert was held at the Burgoyne Bay School, where Miss Furness is teacher, Friday, December 12th. The object was to raise money to provide an organ for the school. About \$30 was collected.

St. Mark's Ladies' Guild has contributed \$5 towards the organ which has been purchased for the Divide School. This, with the concert money and other subscriptions, settles the bill.

At the election held December 23rd Burgoyne Bay stood 11 for Robertson, 35 for Paterson; at Gangès Harbour the poll was 45 for Robertson, 39 for Paterson.

The liquor law in respect to steamboats is that the special license granted them "authorizes the sale of liquor, on such steamer only to the passengers and crew of said steamer, and to said passengers and crew only when the steamer is not at any port."

The Ven. Archdeacon Scriven delivered a sermon on Foreign Missions at St. Mark's Church, Wednesday evening, December 3rd. The offertory amounted to \$5.35. Missionary boxes have been given out as last year, and will be collected at Whitsuntide.

Col. and Mrs. Craig have returned to the Island after their long absence in the Old Country, and are settled once more in their own residence at Ganges Harbour. Their little boy, John, has grown to be a fine little fellow, nearly five years old.

The Christmas Tree Entertainment at the North End School passed off very happily and pleasantly on Thursday, December 18th. The little school was crowded, and the children acquitted themselves well in their songs and recitation. The children presented a nice little gift to their teacher, Miss Maggie Brethour.

Thirty-four persons on Salt Spring Island thus far have signed the following pledge: "I promise to abstain from the use of intoxicating liquors as a beverage, and will discountenance such use by others." Rev. E. F. Wilson, at the North End of the Island, and Miss Mollet, at the South End, will be glad to receive more names.

Owing to the stormy weather, the congregation at St. Mark's Church was only about half its usual size on Christmas Day. The church was prettily decorated with cedar and pine, and some choice hot-house flowers presented by a lady member of the congregation. The offertory for the Clergy, Widows' and Orphans' Fund amounted to \$8.45.

The Board of License Commissioners for this district sat at the Court House on December 15th. Mr. A. R. Bittancourt, of Ganges Harbour, applied for a "hotel license," which would mean keeping a bar and selling liquor to be drunk on the premises. Fifty-two persons had signed their names in favour of Mr. Bittancourt's application, but as the law requires a two-thirds vote, and there were 98 persons cligible to vote within the three-mile limit, the application could not be entertained. Some persons seem to have been under the misapprehension that the application was for a "bottle license," such as the grocers in the towns have, but this was a mistake, as there is no such thing as a "bottle license" outside a municipality.
